### **20/21 Public Participation**

Nigel Smith and Diane Marsh, representing the 'Guardians of the Tarn', joined the meeting; both commented on the Tarn flooding problems, contributing local knowledge to the debate.

They also requested that the Parish Council consider the 'Guardians of the Tarn's' request for a dead Rowan to be felled and a Cherry to be pruned. If after pruning the shape of the Cherry is acceptable then it is to be left; however; if not, then they ask that it be felled also.

The Chair thanked them both for their contribution.

21/0070 – 7 South Esk, Culgaith - Proposed off street car parking and associated works (as per previous consent 15/0735) Supported

## 25/21 Highways and Land Matters

25.1 30-mph Signs – Station Road, Culgaith. – Repositioning  
It was reported that a request had been made to Highways that the start of a 30-mph zone, on the approach to Culgaith, be located before the entrance to the proposed Hazel Dene housing development.

### 25.2 Digital Speed Awareness Device – Culgaith

Reported that the 'Crash' Committee had agreed to a digital sign being erected. A site visit with Highways being planned for late March, to confirm the exact location.

**25.3 Village Green by War Memorial Culgaith – Planting of Wild Flower Beds**

An in-depth discussion ensued over what was planned and how it was to be executed. Concerns were raised that such a planting, in the vicinity of the War Memorial, could compromise the respect in which this location is held. The Victoria Institute had agreed to sponsor the project to a value of £300.

**Action:-** It was hesitantly, but unanimously agreed to proceed with the project, however all Culgaith Councillors were to be involved in the decisions taken over the planting.

(Subsequent to the meeting it was decided not to proceed with this project this year. The Chair wishing to thank Cllr Lesley Benton for all the hard work that she had put into the project to date)

**25.4 Grass Cutting Tender 2021**

Only one tender had been received, that from the current contractor, Mark Binney. Councillors, being well pleased with the excellent job that Mark had done for the last 3 years, unanimously agreed to accept his tender for a further 3-year period. Details being on file.

**25.5 Blencarn ‘Rigg’ – Cows and Calves grazing.**

It was confirmed that: -

**25.5.1** The farmer concerned did have legitimate grazing rights for 20 cows with calves at foot, on the land in question.

**25.5.2** It was permissible to graze cows, with calves at foot, on land crossed by a public right of way; however, the owner of the livestock being liable, should a member of the public, walking on the public right of way, be hurt by one of his animals.

**25.5.3** A farmer grazing animals in such circumstances would be wise to have undertaken a Risk Assessment.

**25.5.4** Should an accident occur; the incident could be investigated by the Health and Safety Executive.

**25.6 Road surface from Culgaith School to War Memorial – In Hand Highways**

**25.7 Flooding Vicinity of Otter’s Holt Entrance – Drainage work Completed**

**25.8 Tarn Flooding Issue**

**25.8.1** It was reported that Highways had jetted a number of drains in the vicinity.

**25.8.2** It was thought that the two drains opposite Kettlestones house were ‘possibly soak away’ drains, being filled by the water level in the Tarn.

**25.8.3** Highways were planning to revisit all the drains in question, including those in Chestnut Close.

**25.8.4** It was decided to see the outcome of this further investigation before any further action was taken.

### **25.9 Tarn Trees to Prune**

It had been requested by the Guardians of the Tarn Committee, that a dead Rowan, by the roadside by the Tarn, be felled and also a Cherry tree be pruned, if after pruning the shape of the Cherry is deemed unsatisfactory, it also should be felled.

**Action** ;- Unanimously agreed to have this work undertake.
