#### 10/22 Highways and Land Matters

## 10.1 Foot path signs

Reported that the Kirkland/Broats, Bramblelands/Lime Tree Farm signs would be replaced by Cumbria County Council shortly. The sign by Tarn Villa would not be replaced until the legal queries had been resolved.

#### 10.2 Potholes and Other Road Issues

10.2.1 Following the Culgaith Digital sign site visit in the Autumn, Cumbria Highways had suggested that initially the entrance signage to Culgaith be reviewed along with additional road markings. Highway had now supplied the Parish Council with a revised signage design for approval, which included '30mph' and 'Please drive carefully' along with 'Culgaith'. (See Attached) **Action:-** It was unanimously agreed to approve this proposed new design, asking that these new signs be installed at all entrances to the village. In addition, either '30 mph' or 'Slow' road markings be painted by each sign.

- 10.2.2 Drainage issue by the Beck Mill entrance had been reported.
- 10.2.3 The Pea to A6412 Junction Drainage issue. Reported.
- 10.2.4 Culgaith Back Lane pothole and poor surface by Drove Road corner.
  Reported
- 10.2.5 Water flowing across road Culgaith / Langwathby road. In hand with Highways.
- 10.2.6 Black Swan Back Road T Junction, potholes and poor road surface. Reported
- 10.2.7 Pot hole Kirkland junction in Blencarn. Reported
- 10.2.8 Lodge/Abbey Farm Entrance Pothole. Reported

10.2.9 Culgaith Faded - White Lines at junctions. Reported 10.2.10 Faded Culgaith school 'No parking' - yellow lines. Reported

10.3 Skirwith Footway Lights – The light opposite Skirwith village hall and the one in front of Pear Tree house are still not functioning. The issue lies with Electricity North West and they are being leaned on by EDC Contracts Department to connect power to them. The Parish Council have requested a supply and maintenance refund.

#### 10.4 Queens Platinum Jubilee Beacon 2022 - On Cross Fell -

It was reported that difficulty was being encountered with regard to obtaining permission to light a beacon on this SSSI site. Councillors agreed to consider covering 50% of the beacon costs with Alston PC; subject to prior approval. (Subsequent to the meeting it can be clarified that the arrangements are in hand, with Alston Parish Council, with regard to attempting to meet the requirements specified by Natural England, to enable them to grant permission. The fact that the top of Cross Fell is an SSSI is presenting problems. It may be easier to achieve the objective by having a 'Medieval Propane Gas' beacon, subject to availability; the hire of which being approximately £250 per week,

#### **10.5** Queens Platinum Jubilee – Other activities or not.

Councillors expressed a view that they felt it was for the village halls or other community organizations, rather than the Parish Council, to organize specific Jubilee Community events. It was reported that EDC had available a £500 grant available per event.
